Century Farm and Ranch Criteria: Applicants must meet the following criteria:

- A Century Farm and Ranch must meet the definition of a Farm and Ranch as set forth in the Utah Farmland Assessment Act (Greenbelt) and has received that designation by the County Assessor.
- The Farm and Ranch must have been in continuous ownership and operation by a family for at least 100 years from the present calendar year back. Except for the original owner, lineal descent must be traced through either a son, daughter, grandson or granddaughter (including in-laws) of the previous owner/operator. Proof of ownership must accompany the application. Records can be obtained from the county recorder.

Instructions: Complete the application and submit to your local County Extension Service Office

- The deadline for receiving applications is **April 1** this year. The County Extension agent will review the information presented and forward the application to the **Utah Farm Bureau**, **9865 S. State Street, Sandy, UT 84070.**
- Should you disagree with the decision of the County Extension agent, you may take your appeal to the State Century Farm Committee for reconsideration.
- Please enclose a check for the amount of \$100. Make payable to: Century Farm and Ranch Committee. (Application fee covers: 2' x 3' metal highway sign, personalized metal name plate, certified certificate, postage and handling.)
