

2019 UTAH FARM BUREAU FEDERATION – UFBF SMOKER GIVEAWAY OFFICIAL RULES

FB PROMOTION: HOLIDAYS UP IN SMOKE GIVEAWAY

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.

DESCRIPTION: The 2019 Utah Farm Bureau Federation – 2019 UTAH FARM BUREAU FEDERATION SMOKER (“GIVEAWAY”) begins at 12:00 AM Mountain Standard Time (“MST”) on 11/15/2019 and ends at 11:59 MST on 12/15/2019 (“Period Giveaway”).

PRIZE: Traeger Pro 575 Grill, cover, shelf, and pellets (approximately \$940 value).

SPONSOR: Utah Farm Bureau Federation, 9865 S. State Street, Sandy, Utah 84070

ADMINISTRATOR: Membership Division

ELIGIBILITY: The Giveaway is open to legal U.S. residents of Utah who are Utah Farm Bureau Federation members as of 11/01/19, and 19 years of age or older at the time of entry (“Entrant”). State and County Employees, agents, directors and officers and their immediate families (if they reside in the same household) (spouses and siblings, parents and children and their spouses) and household members of Utah Farm Bureau Federation (“Sponsor”) [with the exception of county Utah Farm Bureau Federation volunteer Board of Directors], the American Farm Bureau Federation, other U.S. State Farm Bureaus/Federations, and their respective parent companies, subsidiaries and affiliates, distributors, and companies involved in the implementation and execution of the Giveaway (collectively the "Giveaway Entities") are not eligible. Giveaway is offered only in Utah and is void elsewhere and where prohibited.

AGREEMENT TO THE OFFICIAL RULES: By participating in the Giveaway, each participant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Giveaway. LIMIT: One (1) entry per person or registration. In the event that more than one (1) entry is received from any one person or email address, the first Entry processed will be considered the only valid entry received. Should a Participant enter the Giveaway via mobile device, he/she understands that use of the mobile device may be subject to the charges imposed by participant's carrier's rate plan. Proof of sending does not constitute proof of actual receipt by Administrator of an Entry for purposes of this Giveaway. Only eligible Entries actually received by Administrator before the Closing Date will be included in the Giveaway drawing. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations which will be disqualified.

GIVEAWAY WINNER SELECTION: The potential Giveaway Prize winner will be selected in a random drawing conducted on or about 12/16/2019 from among all eligible Entries received. Odds of winning Prize depends on the number of eligible Entries received. Giveaway drawing will be conducted by the Communications Division Vice President (“Administrator”). Potential Prize winner will be contacted by 12/17/2019 by the Administrator by telephone and/or email and will be required to complete and return a Publicity Release Form (“Release”) within three days of receipt. If the Prize notification is rejected, returned, or deemed undeliverable or the potential winner fails to execute and return the Release within the specified time or if he/she is otherwise ineligible to receive the prize, that potential winner will be deemed ineligible and the Prize will be forfeited or awarded to an alternate as solely determined by Sponsor. In the event that the potential Prize winner is disqualified for any reason, that Prize will be forfeited and awarded to an alternate.
